The author's contract (Public offer)

This «The author's contract» (then «Contract») defines the relationship between JSC «Transfer», by an General Director Novikov Boris Alekseevich, an authorized person by the Charter – the Publisher of the magazine «Innovation», which was established by Russian State University of Innovation Technologies and Business, St. Petersburg Electrotechnical University «LETI» and JSC «Transfer»» and was registered by the State Committee of the Russian Federation on the press (the certificate of the registration № PI № 016292 from June 30, 1997), hereinafter called as «Publisher» and the author (or other copyright holder), which take the public offer on basis the contract, hereinafter called as » and the author (or other copyright holder), which take the public offer on basis the contract, hereinafter called as «Author».

1. The subject of Contract

- 1.3 Publisher may conclude contracts with third parties about actions for security of copyright and Publisher's rights without the Author's agreement.
 - 1.4 Author sends copyrighted materials on following conditions:
- means of the using of copyright materials are a publication in the paper issue (the magazine «Innovation»), in websites of Publisher and other websites with which Publisher had made contracts. List of websites with which Publisher had made contracts is presented by websites http://www.maginnov.ru/ or http://журналинновации.рф;
 - using of copyright materials is not limited by a territory;
 - using of copyright materials is free of charge;

- expiration date of Contract is 5 years. After this period Publisher reserves and Author confirms the Publisher's perpetual right to continue to place copyright materials in the Internet in accordance with the clause 1.2. this Contract.
- 1.5 Author guarantee that the using copyright materials by Publisher will not infringe rights of third parties.

2. The order of the conclusion of Contract and the change its conditions

- 2.1 The conditions of Contract are a public offer in accordance with paragraph 2 of Art. 437 of the Civil Code of the Russian Federation.
- 2.2 The conclusion of Contract by Publisher is a publication of the text of Contract by the magazine «Innovation» and epy placing of the text in the Internet.
- 2.3 The conclusion of Contract by Author, that is full and unconditional consent with conditions of Contract, and the realization by Author the next actions:
